The undersigned acknowledges that the terrain of the property and the roads or other conditions that may exist on the property, such as wells, stump holes, excavations, and similar conditions, may be hazardous to the undersigned, and that Licensor and owner(s) makes no representation that any of the same are safe for the purposes of hunting thereon, walking, riding, or otherwise using the same, or for the purposes or use intended by the undersigned. The undersigned further acknowledges that hunting is dangerous, and hereby assumes any and all risks associated herewith.
